Terms and Conditions: Flicker Day Pass Package

Introduction These Terms and Conditions ("Terms") apply to the Flicker Day Pass ("Day Pass") offered by Ember Cowork ("We," "Us," or "Our"), located in Liverpool, UK. By purchasing or using the Flicker Day Pass, you ("User," "You," or "Your") agree to comply with these Terms.

1. Day Pass Details 1.1. The Flicker Day Pass provides the following benefits:

- One day access to the coworking space.
- Access to all amenities provided at Ember Cowork.
- Bookable meeting rooms at a rate of £15 per hour.

2. Booking and Payment

2.1. The Day Pass can be booked and paid for on the same day of use or in advance through Ember Cowork's booking system.

4.2. Users must cancel meeting room bookings at least 24 hours in advance to avoid incurring charges.

4.3. Meeting rooms must be left in a clean and tidy condition. Additional cleaning fees may apply if necessary.

5. Amenities

5.1. Users have access to all amenities provided by Ember Cowork, including but not limited to internet access, kitchen facilities, and communal areas.

5.2. Ember Cowork does not guarantee uninterrupted availability of amenities and will not be held liable for any temporary outages.
