

Ember Cowork - Terms & Conditions

Terms and Conditions: Inferno Membership Package

Introduction

These Terms and Conditions ("Terms") apply to the Inferno Membership Package ("Membership") offered by Ember Cowork ("We," "Us," or "Our"), located in Liverpool, UK. By purchasing or using the Inferno Membership Package, you ("Member," "You," or "Your") agree to comply with these Terms.

1. Membership Details

1.1. The Inferno Membership Package is a 6-month contract providing the following benefits:

- Unlimited visits per month to the coworking space.
- A dedicated desk exclusive to the Member.
- Access to a personal locker and post box.
- Use of Ember Cowork's business address for professional purposes.
- Access to all amenities provided at Ember Cowork.
- Bookable meeting rooms at a rate of £10 per hour.

2. Membership Term and Renewal

2.1. The Membership is a fixed 6-month contract commencing on the date of activation.

2.2. Renewal of the Membership is not automatic. You must notify Ember Cowork of Your intention to renew at least 30 days prior to the end of the current term.

3. Payment and Fees

3.1. The Membership fee is payable in advance on a monthly or lump-sum basis as agreed at the time of purchase.

3.2. Payments must be made by the due date. Late payments may incur a fee of £25 or suspension of Membership access until the outstanding amount is cleared.

3.3. Fees for meeting room bookings are not included in the Membership fee and must be paid separately at the time of booking.

4. Access and Usage

4.1. Members have unlimited access to the coworking space during regular operating hours. Any changes to operating hours will be communicated in advance.

4.2. The dedicated desk, locker, and post box assigned to the Member are for personal use only and may not be shared or subleased.

4.3. Members must adhere to Ember Cowork's Code of Conduct, which includes maintaining a professional and respectful environment.

4.4. Any damage to property or equipment caused by a Member must be reported immediately and may result in charges for repair or replacement.

5. Business Address and Mail Handling

5.1. The business address service allows Members to use Ember Cowork's address for professional purposes, including mail reception.

5.2. Members are responsible for collecting their mail in a timely manner. Mail not collected within 30 days may be disposed of unless prior arrangements are made.

6. Termination

6.1. Members may not terminate the Membership before the end of the 6-month contract period unless otherwise agreed in writing with Ember Cowork.

6.2. Ember Cowork reserves the right to terminate a Membership without refund in cases of breach of these Terms or the Code of Conduct.

6.3. Upon termination, Members must vacate their desk and locker, removing all personal belongings within 7 days. Any items left behind will be disposed of.

7. Meeting Room Bookings

7.1. Meeting rooms are available for booking by Members at the discounted rate of £10 per hour, subject to availability.

7.2. Members must cancel bookings at least 24 hours in advance to avoid incurring charges.

7.3. Meeting rooms must be left in a clean and tidy condition. Additional cleaning fees may apply if necessary.

8. Amenities

8.1. Members have access to all amenities provided by Ember Cowork, including but not limited to internet access, kitchen facilities, and communal areas.

8.2. Ember Cowork does not guarantee uninterrupted availability of amenities and will not be held liable for any temporary outages.

9. Liability and Indemnity

9.1. Ember Cowork is not liable for the loss, theft, or damage of personal property belonging to Members.

9.2. Members agree to indemnify Ember Cowork against any claims, damages, or expenses arising from their use of the coworking space or services.

10. Changes to Terms

10.1. Ember Cowork reserves the right to update these Terms. Members will be notified of any changes, which will take effect 30 days after notification.

11. Governing Law

11.1. These Terms are governed by the laws of England and Wales. Any disputes arising under these Terms shall be subject to the exclusive jurisdiction of the courts in Liverpool, UK.
