

Ember Cowork - Terms & Conditions

Terms and Conditions: Spark Subscription Package

Introduction These Terms and Conditions ("Terms") apply to the Spark Subscription ("Subscription") offered by Ember Cowork ("We," "Us," or "Our"), located in Liverpool, UK. By purchasing or using the Spark Subscription, you ("Subscriber," "You," or "Your") agree to comply with these Terms.

1. Subscription Details 1.1. The Spark Subscription is a rolling monthly contract providing the following benefits:

- Up to 10 visits per month to the coworking space.
- Pre-booked desk space.
- Access to all amenities provided at Ember Cowork.
- Bookable meeting rooms at a rate of £15 per hour.

2. Subscription Term and Renewal

2.1. The Subscription operates on a rolling monthly basis, renewing automatically at the end of each month unless terminated in accordance with these Terms.

2.2. Subscribers must provide at least 14 days' notice to cancel the Subscription before the start of the next billing cycle.

3. Payment and Fees

3.1. The Subscription fee is payable in advance at the beginning of each month.

3.2. Payments must be made by the due date. Late payments may result in suspension of Subscription access until the outstanding amount is cleared.

3.3. Fees for meeting room bookings are not included in the Subscription fee and must be paid separately at the time of booking.

4. Access and Usage

4.1. Subscribers have access to the coworking space during regular operating hours, with a limit of 10 visits per month. Any changes to operating hours will be communicated in advance.

4.2. Desk spaces must be pre-booked through Ember Cowork's booking system and are subject to availability.

4.3. Subscribers must adhere to Ember Cowork's Code of Conduct, which includes maintaining a professional and respectful environment.

4.4. Any damage to property or equipment caused by a Subscriber must be reported immediately and may result in charges for repair or replacement.

5. Meeting Room Bookings

5.1. Meeting rooms are available for booking by Subscribers at the discounted rate of £15 per hour, subject to availability.

5.2. Subscribers must cancel bookings at least 24 hours in advance to avoid incurring charges.

5.3. Meeting rooms must be left in a clean and tidy condition. Additional cleaning fees may apply if necessary.

6. Amenities

6.1. Subscribers have access to all amenities provided by Ember Cowork, including but not limited to internet access, kitchen facilities, and communal areas.

6.2. Ember Cowork does not guarantee uninterrupted availability of amenities and will not be held liable for any temporary outages.

7. Liability and Indemnity

7.1. Ember Cowork is not liable for the loss, theft, or damage of personal property belonging to Subscribers.

7.2. Subscribers agree to indemnify Ember Cowork against any claims, damages, or expenses arising from their use of the coworking space or services.

8. Changes to Terms

8.1. Ember Cowork reserves the right to update these Terms. Subscribers will be notified of any changes, which will take effect 30 days after notification.

9. Governing Law

9.1. These Terms are governed by the laws of England and Wales. Any disputes arising under these Terms shall be subject to the exclusive jurisdiction of the courts in Liverpool, UK.
